## **ORDER**

As per Government Order read above, Government have fixed the charges for Rapid RTPCR test by Abott Health Care Pvt Ltd and Thermo Fishre Scientific India Pvt Ltd established at airports as Rs. 2490/-.

- 2) As instructed, the Managing Director, Kerala Medical Services Corporation Limited has collected the details on the Rapid PCR tests at the departure/arrival sections at all the airports in the State. As certain countries demands Rapid PCR test result within the specific time, the agency entrusted by Airport Authority of India are conducting Rapid PCR test at the departure section of the airports at the cost of the passenger.
- 3) Kerala Medical Services Corporation Limited has invited open quotation from private labs for conducting Rapid PCR tests within the airport for passengers coming, during the 3<sup>rd</sup> wave. Different type of tests were offered by private laboratories for Rapid PCR tests.
- 4) Based on this, the Managing Director, Kerala Medical Services Corporation Limited has furnished detailed proposal with the list of firms quoted the lowest rates with various technologies for conducting Rapid PCR tests, at airports.
