ORDER

As part of the Malinya muktam navakeralam initiative, Government is committed to digitization of waste management activities. In this connection, 3 important areas were identified for digitized information systems, monitoring and coordination:

1. Haritha mithram app – data management, supervision and grievance redressal at LSG , District and State levels, including data interpretation and analysis
2. GPS based tracking of movement of all vehicles involved in waste management – to centrally monitor and identify violations for immediate response and correction. Linking MCFs and RRFs with transport systems for integrated management of waste movement
3. Linking all surveillance camera feeds for real time capture of violations and misbehaviour to expedite corrective response

In furtherance of this objective, Government have decided to create an IT application for the tracking and management of vehicles involved in Waste Management and develop an IT application for effectively converging and managing camera feeds used in waste management. In order to call for and examine proposals received through Kerala Startup Mission (KSUM) towards the procurement of these apps,, Government hereby forms a committee with the following members.

The aforementioned committee is empowered to:

- a. Collaborate with the Kerala Startup Mission (KSUM) to solicit proposals from startups offering solutions for the above mentioned problem statements.
- b. Evaluate the received proposals, liaise with KSUM and the IT Department, and subsequently submit the selected proposal to the Local Self-Government Department. The Government guidelines for the procurement of products from startups should be followed.

Funds for developing these applications and operationalising them are to be met from the funds available with the suchitwa mission under suchitwa keralam and swachh bharat.
